#### 4. Traceability:

### 5. Migration Limits:

- Migration tests are conducted by a certified lab or internally using recognized methods, demonstrating that the migration of substances from the film into food simulants does not exceed regulatory limits under foreseeable conditions of use. Test reports are available upon request.

• All raw materials (e.g., polyolefin resins, additives, master batches) used in the production of these shrink films are sourced from approved suppliers and comply with the aforementioned direct/Indirect food contact regulations.
